- Implementation of the project to 2023 in accordance with the implementation of Air Quality Plan
- Accelerate the implementation of Air Quality Plan for Małopolska Region
- Accelerate the implementation of the resolution on the prohibition of the use of solid fuels in Kraków
- Increasing the use of funds from Regional Operational Programme for the exchange of heating systems, thermo-modernization of buildings and sustainable urban transport

Actions in LIFE IP





- Employment of Eco-managers in 39 municipalities, who will lead to faster implementation of actions to reduce emissions
- Establishment of Excellence Center to support municipalities for implementation of Air Quality Plan
 - Creation of knowledge base
 - Transfer of knowledge
 - Support and advice to municipalities

Eco-managers





- Effective implementation of the Air Quality Plan depends mainly on the activities in the municipalities
- A major limitation is the lack of a sufficient number of employees in the municipalities who would lead actions to reduce emissions
- 39 municipalities in Małopolska have declared participation in the LIFE IP and the employment of eco-managers



Eco-managers





Eco-managers





- Eco-managers will assist municipalities in
 obtaining funds from various sources, mainly from
 the Regional Operational Programme for the
 reduction of emissions
- Eco-managers will encourage residents to replace a heating system and assist them in gaining grants for this purpose

Actions in LIFE IP





- Assistance for City of Krakow in dealing with applications for a grant for the exchange of coal boilers
- Professional consultation centers for residents who want to change the heating system or perform thermo-modernization of the building

LIFE IP in Małopolska





- Implementation of high resulotion modeling to evaluate the impact of planned changes to the transport in Krakow on air quality
- Large public campaign on regional and local level
- Estimated value of the project: 17 million Euro

Additional actions





- Replacing coal boilers, thermo-modernization of buildings and sustainable urban transport using funds from:
 - Regional Operational Programme,
 - Operational Programme Infrastructure and Environment on national level,
 - National Fund for Environmental Protection and Water Management,
 - Regional Fund for Environmental Protection and Water Management in Kraków,
 - Local budgets.
- Total value: 700 mln Euro.







- 2nd of March 2015 submit full proposal with final budget for LIFE IP to National Fund for Environmental Protection and Water Management
- 17th of April 2015 submit full proposal for LIFE IP to European Commision
- 1st of October 2015 possible start of LIFE IP





Project implementation

Phase I: 01/10/2015 – 31/12/2017

Phase II: 01/01/2018 - 31/12/2019

Phase III: 01/01/2020 – 31/12/2021

Phase IV: 01/01/2022 – 31/12/2023



Cooperation between regions
